Albert Micco, of 1711 31st St. NE, was present to ask questions about four-wheelers in the park at the end of his street, which is a Canton City Park. Sgt. Curry informed him that they are not legal on the street and that he should probably contact the Canton City Parks Director about this problem.

Kim Jackson of 152 35th St., said that he has watched this house decline over the years. It is an eyesore and it has declined property values around it.

Linda Voneman, of 1717 31st St. NE, said they had a problem with a sewer backup in their basements. It is sanitary sewer. Mr. Giavasis said they would have to ascertain where the storm water is getting into the sanitary sewer and see who is responsible for it and find out how it could be fixed and he would get back to the residents in the future after consulting with the Sanitary Sewer Engineer and Joe Iacino at the scene.

David Miner, of 4806 Darlington NW, as president of the North Avondale Homeowners Association, said that he had three areas of concern. One was the S.H. Kim property, which was on the nuisance abatement this evening. Secondly, 50th St. NW has been flooding about 200 feet east of Whipple for nearly five to ten years. He said that at the time they built their homes or bought their homes or when Kinetix was developed, the Trustees said that the S.H. Kim property would be developed and it should take care of itself. The remainder of the S.H. Kim property had never been developed, so he would like something to be looked into to alleviate the flooding problem. Thirdly, he said that 47th St. has become the major ingress and egress in and out of their allotment. However, on Bethel to Sharonwood there is a width problem and they do have a handicapped home within the neighborhood that has SARTA buses and school buses coming to it on a weekly basis. He was suggesting that the width be looked at on Bethel to Sharonwood because it is a 30 foot width and the Township would have some right-of-way to possibly widen it. He said that some residents have complained that their mirrors almost touch when they go down the street.

Chief Sabo then gave an update on the demolition of the S.H. Kim property and explained to Mr. Miner that the property in question had a date in late August for all the of the lien holders to comply. After that he would be contacting the demolition party to continue with the demolition process of those properties.

Mark Enot was present with regard to the lighting district. He was late and didn't know that it was going to be on early. Mr. Shriver explained to him that the problem was he needed to sign the petition since he was the property owner. Mr. Shriver said he would get with him after the meeting and have him sign a petition and resubmit this for the hearing since it was held over to the next meeting.

CONCERNS OF TRUSTEES:

Mr. Leno wanted to state that at the meeting of June 22 with regard to

Resolution #04-406 in the hiring of temporary help within the office, that he did not feel it was necessary; however, it was a very hectic meeting and he wanted to publicly within these minutes let it be known that he is not in favor of that particular resolution to hire any temporary help. He feels with the new phone system and after talking with Kelly Boggs and understanding how the phone system works, the work within the office if someone is out sick or on vacation can be handled with teamwork and everyone filling in, especially with the cost of the new phone system. However, he did want to go on record with Resolution #04-406 that his vote would be no and he is not in favor of hiring any temporary help in the office.
