Mr. Leno expressed his desire to work with the committee and said that his experience has taught him that once the committee is formed, it is exciting and rolls right along and everybody does their job. Tom said that they had planned on some historical publications and also making a list of historical homes in the Township. There were suggestions about individuals to be asked to chair the steering committee; also a cochair and then six to eight committee chairmen. The idea about a time capsule and planting an elm tree was discussed as well as the sale of elm trees. Mr. Bryan Rice will also be asked to be involved with this committee.
