Approximately the 2nd week of May the entire plaza will be uplifted with newly painted façade. It will be stripped and painted. The parking lot will be cleaned up, holes refilled and striped and resealed. They put out over 234 letters to prospective tenants for the anchor building, 500 who seem to fit. However the problem is with no anchor it is a stopping point in getting the plaza filled up. He did indicate it is still a problem with Giant Eagle in fact that they hold the lease and have turned down in the past prospective grocer tenants. Mr. Sylvio Pilligi who has been in the restaurant business in the plaza for three years was present to complain about the plaza and wants to start a coalition against Giant Eagle. It was pointed out by Mr. Giavasis that the former owners of the plaza would not communicate with Plain Township as to what was going on but at least Mr. Wilson was communicating and being forthright with the Board as to their efforts in trying to get the Plaza occupied.

- Stormwater Mapping due to EPA mandates Lisa went over a program whereby the Regional Planning Commission will take the project, field collection of our inventory of our conveyances, any water moving in and out of pipes, storm sewers we have, etc. This project will cost will cost around \$130,000 over a five year period. If it were not for RPC doing this, as it is mandated, we would have to come up with the money ourselves and hire employees. It was the feeling of the Board, Lisa and Joe that this was the way to go. There are other overlays that could be involved later such as inventory of signs, fire hydrants, traffic control devices, etc.
