1. Yearly Report

The yearly report was given by Detective Hostetler. He said the total calls were 16,330 in 2011 compared to 17,110 in 2010. The reports were down to a total of 5168 compared to 5838 in 2010. Traffic citations were down 28.8% at 2315. Crash reports were up 4.9%; robbery-in-progress report was 1; burglary was down 2.54%. Vehicle maintenance stood at under 0.5¢ per vehicle. Thirteen of the cars have over 100,000 on them. Vehicle replacement was discussed. Investigations were at 237 cases assigned with 115 being closed with arrests and out of the 237, 118 were burglaries.

- 2. Tony Paone 5676 Linder Circle NE read an article regarding methane in the water and wanted to know who notified the Township. Where they notified by the State, County or Health Department regarding the methane in the water. Mr. Giavasis said he talked with Paul DePasquale who is with an investigator. We have not been contacted by ODNR, however, he did say Mr. DePasquale said there many sources for the methane; it could be pre-existing and that ODNR was the only official agency that could do the actual testing to find out the origin of the problem.

CONCERNS OF TRUSTEES:

House Bill Amendment 386, HB 50 and OTA-CLOUT commissioned report on cost of government Bill 386 which is a bill that says that 50% of the money from casinos would come back to municipalities. This bill is of special interest to the Trustees and should be to the Township as it is not really explicit as to how much of that 50% of the money would go to the Township. Mr. Giavasis reported as of today there was a vote and it did go back to committee so the township would still have a chance to voice their concerns. With regard to HB 50, Mr. Haws said this had to do with some annexation language that would give more rights to the township; however, when it came it out it was washed out and rather weak. He expressed the need for the Trustees of all townships to be more vocal at the State level. He also talked about the CLOUT meeting he attended. There was a report from the Toledo University that attempted to claim the township government was more expensive; however, there was no backing to prove it. The Ohio Township Association will commission a study. Mr. Giavasis pointed out that our budget for 40,000 residents is \$18 million and the City of North Canton has a \$40 million budget and they only have 17,000 residents. He said if you just look at those numbers it will probably tell you that township government is more effective.
