Emery addressed The Board to express concern about the cost of the Parks Levy for those on a fixed income. Emery asked if there was an alternative to the levy such as sales tax. Mr. Sabo explained to **Emery that Townships don’t have the authority to impose** a sales tax. Emery suggested more user fees so that the homeowners do not have to pay the levy. Mr. Sabo explained that The Township gets a lot of requests to expand and improve the parks programming. Mr. Sabo explained that the only way the Trustees can truly know if the majority of residents want more parks programming and improvements is by putting it on the ballot. Mr. Sabo encouraged Emery to come to the next Park Levy Town Hall to get more information. Emery also expressed concerns about the yard waste drop off locations and the hours of operation. Mr. Sabo explained that the costs for hauling the yard waste has increased over recent years and the grant funding from the Joint Solid Waste District has been cut. Lisa explained that the tentative hours for yard waste are subject to change after the Township evaluates the year to date costs and grant funds remaining.
