## A Message from the Board of Trustees & Fiscal Officer

Plain Township is seeking a 2.25 mill, five-year replacement of its police levy. The current police levy will expire in 2012. This small levy is the only source of funds for the police protection in Plain Township.

Plain Township currently has a contract with the Stark County Sheriff's Department, in which the township is provided with fifteen deputies, including a detective assigned exclusively to Plain Township.

The Sheriff's Office provides a wide range of services, including patrolling Plain Township's roads and neighborhoods as well as conducting investigations of criminal and civil complaints in our community. These vital police services help keep our township safe.

All equipment used for police services are owned by Plain Township, including the police cruisers. Unfortunately, over the past several years, costs of the equipment and the contract for police services has grown. Couple this with deep state government cuts to our Local Government Fund and the loss of other revenues available to townships, and it has become increasingly difficult to maintain the current level of police services that our citizens need and deserve.

It is for these reasons that the Plain Township Board of Trustees has put our 2.25 mill police levy on the November ballot. This levy is for the same millage we currently have. The replacement merely adjusts for inflation over time. The

additional cost of this levy for the owner of a \$100,000 home will be about \$10.32 more per year.

We understand the economic burdens township taxpayers are facing, and the fact that there are numerous tax issues on the ballot. However, without the passage of this levy, Plain Township will be without policing services at the end of 2012.

Plain Township has excellent police services at a reasonable cost. Safe streets and neighborhoods are a vital component to making the Plain Township community a great place to live, work and worship.

The Plain Township Board of Trustees will always work to keep our homes and our neighborhoods safe.

## Electric Aggregate

On November 8, voters in Plain Township will have the opportunity to adopt an opt-out electric aggregation program in which community officials bring citizens together to buy electricity as a group and negotiate the terms, conditions and price of the electric supply on the group's behalf. This type of group buying power is an effective way to obtain a lower electricity rate for all members of the group.

Ohio law allows for communities—such as townships, cities and counties—to form aggregated buying groups to purchase electric generation on behalf of their citizens. All eligible residents and small business customers in the community are automatically enrolled unless they choose to opt-out. Residents do not need to do anything to join the program. However, anyone who does not wish to participate in the program can easily opt-out by returning a form mailed to all eligible members.

By voting in favor of the electric aggregation, community members will be allowing locally elected officials to act as a buying agent and purchase electric generation at a discounted rate for the community. Members will also have the choice to either participate in the discount program or opt-out.

Residents who vote against the issue will be indicating that they do not want local officials to negotiate an electric generation discount on their behalf.

If voters approve the ballot issue, a letter will be sent to eligible residents and small businesses specifying the terms and

conditions of the offer, as well as the rate. The letter will also contain the opt-out form that can be completed and returned if the consumer does not want to participate in the aggregation program. Consumers have 21 days to opt-out of the program at no charge—and another opportunity to opt-out every three years.

Meetings to discuss the electric aggregate program will be held on October 24 and November 2 at 7:00 p.m. at the Plain Township Hall.

Ohio Power will continue to be responsible for the delivery of power to homes and businesses and will continue to read your meter, maintain poles and wires and restore power after an outage.

Two meetings have been scheduled to discuss the electric aggregate program. These meetings will be held at the Plain Township Hall, 2600 Easton Street NE, on October 24 and November 2 at 7:00 p.m.

## Proper Discharge of Swimming Pool Water

### Drain Your Pool in an Approved Manner

When swimming season is over, pool owners need to be careful of how and where they discharge swimming pool water when they lower the level of their pool. The discharge of chlorinated swimming pool water directly into a waterway or into a storm sewer is prohibited.

The storm sewer system (which includes ditches and pipes) was designed to handle runoff from rain and snow only. The water is not treated before it is discharged into area creeks and rivers. If the water contains chlorine, it can be very toxic to fish and other aquatic animals.

Therefore, residential swimming pool water must be dechlorinated before being discharged. *Do not allow pool water to discharge to a septic system.*

### Dechlorinate Pool Water Before Discharging

Reduce the chlorine in the pool water to undetectable levels before draining it. The simplest method is to stop adding chlorine to your uncovered pool and wait. Sunlight will naturally dissipate the chlorine within a few days. It can also be reduced by adding a chemical called sodium thiosulfate, which is available at pool stores. Monitor the chlorine level with a swimming pool chlorine test kit. When there is no longer any detectable chlorine in your swimming pool, it is safe to discharge the water. When discharging the water, allow it to flow into a grassy area at a slow rate to allow for some filtration of the water.

### Saltwater Swimming Pools

The recent increase in popularity of saltwater swimming pools has caused many to examine the best method for discharging this type of water. At this time, it is still undecided. The bottom line is that some smaller bodies of water can be more severely affected due to the higher salinity of the discharge water. Please exercise caution.

In any circumstance, the township, village or city may prohibit any discharge if there is abuse.

## Board Positions Available

The Plain Township Trustees are accepting letters of intent from those interested in filling expiring terms for the Board of Zoning Appeals and the Zoning Commission. One position to each board will be appointed for a five year term to begin January 2012.

## Certificate of Conformance

All commercial property owners and tenants are required to obtain a Certificate of Conformance Permit *prior* to anyone occupying a building in a Business, Office or Industrial District. A *new* permit is

required for any change in business use, ownership, or tenant.

You can pick up an application at the Plain Township Zoning Department.

## Sign Permits

Almost any temporary sign requires a sign permit, so before you put out that next banner or portable sign, make sure you have obtained your sign permit from the Zoning Department.

A temporary sign permit is good for thirty days. You may put out a temporary sign for two months out of a six month time period. Please apply for and obtain your Temporary Sign Permit *before* placing it outside of your business.

All permanent signs require permits. Please check with the Zoning Department for size requirements.

## Sight Obstructions

Please trim back your trees, bushes, hedges, etc. that may cause a sight problem for drivers, as the courts have determined that there may be a joint liability between the owner and the governmental agency for hazards in the right-of-way.

## Right-of-Way

Please remember that trash cans and portable or permanent basketball hoops cannot be placed in the road right-of-way. According to ORC Section 3767.15, no obstruction can be placed in the right-of-way.

## Prevent Drainage Problems

Please remember not to rake leaves, grass clippings, animal waste or other debris into storm sewers, ditches or streets. Keeping storm sewers and ditches clean will help reduce drainage problems. Your cooperation is appreciated.

Also remember that it is illegal to dump oil, anti-freeze, herbicides, pesticides or other hazardous products into ditches, culverts or catch basins. All violators will be prosecuted. If you see dumping taking place, please report it to the Stark County Health Department at (330) 493-9904.

## Stormwater Curb Marking

We are currently seeking volunteers for the Plain Township Stormwater Curb Marking Program. We need groups of four or more such as Boy Scouts, Girl Scouts, youth groups or anyone else who may be interested.

What is stormwater curb marking? Curb marking is a coordinated effort to apply educational messages on local storm drains and basins that flow into vital bodies of water.

The purpose of curb marking storm drains is to reduce or eliminate NPS pollution. Stenciling the words "Do Not Dump, Drains To Lake" warns the community not to dump pollutants in catch basins.
